1. BCIN BV POCESSING CONTROL HANDLING

In line with the planned customer database transition, the transaction/function BCIN BV will be abolished as of July 1st, 2013. Covering the same functional scope, the new function BUXK BV will be offered instead. If you need to have access to this new function, then you are kindly requested to approach your company's security administrator in order for the new function to be made accessible to you. Access to the new transaction can be set up from now on. Function calls will be allowed as of July 1st, 2013.

2. Removal of transactions not used any longer for Frankfurt exchange location

Since May 2011, XONTRO has not been used for exchange price fixing procedures at the Frankfurt Stock Exchange any more. Those functions having become obsolete by this means will thus now be removed from XONTRO one by one. Therefore, beginning Monday, June 10th, 2013, the following transactions may not be used any longer:

- BCEB Order entry and modification
- BCIO Order information services
- BCHI Order history

3. High frequency trading law

As viewed from today's perspective, it is planned to extend the system interfaces SAKI-SWIFT and SAKI-FIX by a new field "regulatoryID" within the order entry, modification, and deletion area, in order to classify them as algorithmic orders. More detailled information will be ready to be distributed by BrainTrade most likely by the end of June 2013.

4. Order deletion lists at year end procedure

As had already been announced at the end of the year 2012, beginning at the end of the year 2013 the year end order deletion procedure will not take place any longer. BrainTrade would like to stress the fact that, by this means, the distribution of the order deletion lists will be suspended, too. Therefore, our customers are kindly asked to inform their "technical" staff that the job named J%190219 may be deallocated with immediate effect at the customer's site.
